This is a fun non-sanctioned event open to all breeds. The number of entries is limited to 100 dogs. Course design includes agility obstacles with a 20 inch jump height on dirt. Scoring is based on a faults plus time basis. The decisions of the judges are final. The top 10 dogs from the preliminary round will go on to the finals in reverse order of fastest time. Dogs must be on leash at all times except when in the competition ring. Owners are responsible for cleaning up after their dogs. Owner must check in at Horse Show Office to receive their competition number which must be worn during the competition. Entries close and must be postmarked by August 31, 2007.

I am fully aware and acknowledge that dog sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). I AGREE to release the Competition from all claims for money damages or otherwise for any Harm to me or my dog and for any Harm caused by me or my dog to others, even if the Harm resulted, directly or indirectly, from the negligence of the Competition. I AGREE to expressly assume all risks of Harm to me or my dog, including Harm resulting from the negligence of the Competition. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold them harmless with respect to claims for Harm to me or my dog, and for claims made by others for any Harm caused by me or my dog at the Competition. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to assume all of the obligations of this Release on the child's behalf.
